Requirements for Litter Registrations

Please read the Litter Registration Policy given below.

Before your pup certificates can be issued, you need to send to the Registrar ALL of the following:

- a) Notice of intention To Register Litter to be received by registrar as soon as pups have whelped.
- b) Copy of Sire/Dam pedigree UNLESS they have an ABS Inc. Registration number themselves. These must be received by registrar when pups are 4 weeks of age.
- c) Good photograph of Sire and Dam- UNLESS they have had previously ABS Inc. Registered litters. These can be emailed. They must be received by Registrar when pups are 4 weeks of age.
- d) The ABS Inc. Stud Certificate (completed & signed by Stud Owner) to be received by registrar when pups are 4 weeks of age.
- e) The ABS Inc. Health Certificate (Sire & Dam). To be received by Registrar when pups are 4 weeks of age.
- f) The ABS Inc. Litter Registration Form. To be received by Registrar by time pups are 12 weeks of age. Fully completed with their microchip numbers & new owners names / contact details.
- g) Good photograph of each puppy (individually labeled with name) being registered. These can be emailed. Please note the following:
 - Pups must be 5 weeks old or over when photographed
 - Pups must be photographed on their level: i.e. not above them, angled down etc- they maybe held (but not obscured by arms)
 - One front on shot and one side on shot – close up of the pup
 - No other dogs/pups to be in the photograph
- h) Cost per puppy, paid to The ABS Inc., either by : direct deposit (please contact me for details), cheque / money order is AUD\$25.00 per pup certificate for pups up to 12 weeks of age, and AUD\$40 per pup certificate for pups over 12 weeks of age. Plus an additional charge of \$5.00 to cover the costs of registered post for the safe delivery of all certificates per litter.
- i) Please note you have the option to request the Registrar to stamp pup's certificate "NOT FOR BREEDING without prior approval by The ABS Inc. Management Committee" - should there be a pup not of appropriate type or health concerns etc.
- j) Please note ALL MEMBERSHIP APPLICATION FORMS and ALL Hip/Elbow & DNA (if required) and LITTER REGISTRATION FORMS to the Registrar with monies transferred before Certificates can be issued.

The above information should be sent to the registrar preferably by the time frames explained above. Remember all pups must be micro-chipped and the micro-chip number, put on the registration form. If you are able to have all relevant information completed earlier than at 12 weeks, please feel free to send them in.

BY 12 WEEKS AFTER LITTER IS WHELPED, the following MUST be sent to the registrar:

- a) The ABS Inc. Litter Health Form
- b) A complete list of pup buyers' names and contact details.

(If you do not have all the pups sold by 12 weeks of age, you can still send in all forms listed (a) to (f) above to take advantage of the discounted price, but be sure to send in the litter health form and complete list of buyers as soon as possible.

Please note: The Members of The ABS Inc. can place pup photos & contact details on the Australasian Bosdogs Available Facebook page after supplying all relevant information (i.e. Notice of Intention to Register Litter, Stud Certificates and Adult Health Forms) to the Registrar before pups are 4 weeks of age. Only then can they be advertised.

Providing ALL of the above information is YOUR responsibility.

Failure to comply with the above, can lead to:

- a) Possible refusal to register any further litters
- b) Possible termination of ABS Inc. membership under Section 9c (iv) "Prejudicial to the ... interests of the association"
- c) Possible Breaches of the ABS Inc Code of Ethics can result in Official Warnings with you having to supply 'just cause' as to why your Membership is not terminated (depending on severity) OR automatic termination of Membership after three Official Warnings as Minuted in 2011.

Management Committee is sure breeders will understand that it is imperative that registration details be properly completed.
